Child Artists (Below School Leaving Age)	£60 per day (includes full buyout – no additional uplift required). Do not use Equity terms.														

- i) **Walk-ons and Supporting Artists:**
 - a. a **Basic Day** refers to a 9 hours day including a one hour break. Overtime commences nine hours after the time they are called.
 - b. **Night-work** is work between 10pm and 7am which is either scheduled (excluding overtime) to extend beyond midnight or to begin at 10pm
- ii) **Featured Artists:**
 - a. **Night Work** is work between midnight and 7am which is either scheduled (excluding overtime) to extend beyond midnight or to begin from midnight.
 - b. **Early Call** is work scheduled to commence between 5am and 7am
- iii) **A buy-out MUST be acquired.** It allows unlimited use of an artist's contribution in perpetuity throughout the world. Supporting and child artist fees are already buy-outs. **Walk-ons and featured artists must be paid an additional 100% of their basic rate to buyout.**
